The purpose of Chief Hughes' presentation is to educate you on the possible, not because we expect something to occur, but because we want you to be prepared and educated should some sort of emergency situation occur during a City Council meeting, study session or other public event. The presentation will give you some guidance to make our public meetings, as safe as possible for all who attend. Chief Hughes will walk you through the procedures we have in place today and will give you some examples of incidents that have occurred.

This portion of the City Council Study Session should take no more than 30 minutes.

Recommended Action:

The City Council is asked to participate in this preparedness exercise and become educated on potential threats and possible options to consider increasing Council and citizen safety.
