PARKING CITATIONS


- FIRST 14 DAYS AFTER WRITTEN CAN BE PAID AT THE FINANCE WINDOW AT \$25.00.
- AFTER 14 DAYS AND PAID PRIOR TO COURT DATE – FINE \$25.00/COSTS \$32.50 = TOTAL \$57.50

NOTE: If given a seatbelt violation IN ADDITION TO ANOTHER CHARGE: ADD \$10.00 to amount below  
NOTE: If citation indicates it occurred within a CONSTRUCTION ZONE: ADD \$35.00 to amount below

SCHEDULE OF FINE/COSTS FOR VIOLATION BUREAU

The following traffic and ordinance violations may be satisfied through the Violation Bureau at the Municipal Court office, in lieu of court appearance, according to the procedures listed below:

NOTE: Any situation that does not fall within the parameters below, such as different owner of animal/vehicle, no longer had dog/vehicle, etc requires a court appearance.

---

1<sup>st</sup> offense for Failure to Register Animal- \$50 Fine plus cost = \$82.50  
Plus proof

Defendant must:

- provide proof of current animal license for animal specified on citation,
- sign a plea of guilty, and
- pay fine & costs in full, all at the same time, prior to the assigned court date

OR must appear in court

1<sup>st</sup> offense for Allowing Animal to Run at Large- \$50 Fine plus cost = \$82.50  
Plus proof

Defendant must:

- provide proof of current animal license for animal specified on citation,
- sign a plea of guilty, and
- pay fine & costs in full, all at the same time, prior to the assigned court date

OR must appear in court

1<sup>st</sup> offense for Failure to Provide Proof of Valid Insurance- \$100 Fine plus costs = \$132.50  
Plus proof

Defendant must:

- provide proof of insurance now obtained after the date of offense,
- sign a plea of guilty, and
- pay fine & costs in full, all at the same time and prior to the assigned court date,

OR must appear in court.
